NORTH KOREAN SANCTIONS ADVISORY (NMA_C30.2018.Rev.4)

PURPOSE:

Notify ship owners/manager/operators/insurers/ROs on the North Korea Sanctions Advisory issued by the U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC) on 21 March 2019 titled "Updated Guidance on Addressing North Korea's Illicit Shipping Practices" appended in this circular. This latest US OFAC Advisory updates an earlier publication on 23 February 2018 and provides useful information relating to the deceptive shipping practices used by NK to evade U.S. and UN sanctions which exposes parties involved in the shipping industry, such as insurers, flag States, shipping companies, and financial institutions, to significant sanction risks, as well as measures that parties may implement to mitigate such risks.

The Nauru Maritime Administration takes a strict stance towards upholding U.S. and UN sanctions and will not tolerate any Nauru-flagged vessels who circumvent sanctions against North Korea. Any Nauru-flagged vessels found to be carrying out illicit shipping practices with North Korea shall be de-registered without notice and any new vessel registrations found to be involved in such similar practices or listed in Annexes 2, 4 and 5 of the advisory will be rejected without cause.
