REQUIREMENTS FOR MAINTENANCE, THOROUGH EXAMINATION, OPERATIONAL TESTING, OVERHAUL AND REPAIR OF LIFEBOATS AND RESCUE BOATS, LAUNCHING APPLIANCES AND RELEASE GEAR (NMA_C41.2020.REV.0)

PURPOSE

The purpose of this shipping circular is disseminate the requirements relating to maintenance, thorough examination, operational testing, overhaul and repair of lifeboats and rescue boats, launching appliances and release gear.

APPLICATION

This Circular is relevant and applicable to all Nauru flagged vessels.

CONTENTS:

With the adoption of amendments to regulations III/3 and III/20 of SOLAS by resolution MSC.404(96) from 01 January 2020, the maintenance, thorough examination, operational testing, overhaul and repair of the following items shall be carried out in accordance with the [IMO Resolution MSC.402\(96\)](#):

1. Lifeboats (including free-fall lifeboats), rescue boats and fast rescue boats.
2. Launching appliances as well as on-load and off-load release gears for lifeboats (including primary and secondary means of launching appliances for free-fall lifeboats), rescue boats, fast rescue boats and davit-launched life rafts.

Additionally, Annex 2.2.1 and 3.1 of [IMO Resolution MSC.402\(96\)](#) requires the above to be carried out by service providers authorized by the flag administrations. In this regard, the Nauru Maritime Administration confirms that service providers meeting the following conditions will be recognized as authorized service providers:

1. Authorized by a Recognized Organization (RO) of Nauru (<http://www.naurumaritime.com/ro>); or
2. Authorized by other flag administrations or their ROs.
