### **(a) DEFINITIONS:**

The following terms shall mean:

1. "Administration" – Nauru Maritime Administration.
2. "BUNKER" – International Convention on Civil Liability of Bunker Oil Pollution Damage, 2001.
3. "CLC" – International Convention on Civil Liability for Oil Pollution Damage, 1992.
4. "MLC" – Maritime Labour Convention, 2006.
5. "P&I Club / Insurer" - a recognized Protection and Indemnity Club, mutual association, fixed premium provider, insurer, workers' compensation provider, or other financial security provider accepted by the Administration.
6. "WRC" – Nairobi International Convention on the Removal of Wrecks, 2007.

### **(b) PURPOSE:**

To provide the list of P&I clubs / Insurers whose P&I covers are recognized for Nauru-flagged vessels, and also accepted as issuers of Blue Cards for BUNKER, CLC, WRC, and MLC.
